NOTICE OF MEETING


Notice is hereby given to all interested members of the public that the Board of Directors (“Board”) of the above captioned District will hold a meeting open to the public which, in light of the recent pandemic and national/local emergency declarations, and in conjunction with the most recent executive action by Texas Governor Abbott regarding the Texas Open Meetings Act, will be held via videoconference (**see bottom of this Notice and District website for further details: <http://nwHCMUD24.com>). The meeting will be held on **Tuesday, August 4, 2020, at 7:00 p.m.**, to consider and authorize any action related to the following:

- 1) Minutes of prior Board meeting(s);
- 2) Public comments (*note public comment policy in effect*);
- 3) Law Enforcement Report;
- 4) Tax Assessor’s Report, including:
 - a) Payment of invoices;
 - b) Collection/uncollectible accounts;
- 5) Delinquent Tax Attorney’s Report, including update on additional penalty matters/collection deferrals;
- 6) Financial Advisor’s tax rate recommendation for 2020;
- 7) Bookkeeper’s Report, including:
 - a) Financial and investment reports;
 - b) Payment of invoices;
 - c) Director attendance at AWBD Summer Conference (*August 6-8, remote-only*);
 - d) Review draft operating budget for next fiscal year (ending September 30, 2021)
- 8) Update on electricity aggregation pool and possible contract amendment/extension;
